## MEMORANDUM OF UNDERSTANDING

(at site Synergy Superspeciality Hospital, Rajkot), a company incorporated under the provisions of the Companies Act, 1956, and having its Registered Office at 150 Feet Ring Road, Opp. Gokul Mathura Apartment, Ayodhya Chowk, Rajkot – 360007 (Guj.) which expression shall, where the context so require or admits, be deemed to include the executors, successors, administrators and assignees hereinafter referred to as First Party and/or "The Hospital"

Rajkot Branch of WIRC of ICAI, having its Registered Office at "ICAI Bhawan", Giriraj Nagar Main Road, Nr. JMC Nagar, Off 150 Feet Ring Road, Nr. Raiya Circle, Rajkot - 360007 (Guj.) hereinafter referring to as Second Party which expression shall, where the context so requires or admits, be deemed to include its executors, successors, administrators and assignees.

### Whereas

- The first party is running a Super Specialty Hospital at Rajkot with most modern and 1. advanced medical and paramedical facilities.
- Second Party, for its members, Staff and dependents has submitted a proposal for 2. availing cash billing system facility towards their medical treatments.
- The First Party has accepted the proposal of second party for providing cash billing 3. system and providing priority services for its members, Staff, Students and their dependents for Outdoor and Indoor patient treatment under the following terms and conditions.

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSES AND IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

That the Second party will send the patient with self-identification card on priority and if it is not available at the time of taking admission then and an authorization letter from Rajkot Branch of WIRC of ICAI validating the membership of the individual for getting the treatment in the hospital of first party stating clearly that bill will be paid by the individual directly to the first party.

- 3. The patient will produce self-identification card or authorization letter, if fail to provide then treatment will be charged as per Hospital policy.
- 4. That the treatment to the patient will be provided on the terms and conditions as agreed by and between the parties.
- 5. That the First party shall provide medicines and charges through the hospital bill for IPD treatment.
- 6. That "the Hospital" shall obtain signatures of the patient in every case to certify that the treatment given to him and shall countersign the Prescription and details of medicines at the time of the discharge.

That the terms and conditions of the agreement will be reviewed after every 24 months. No modification, variation, waiver or amendment of any term or condition of this agreement shall be effective unless and until it shall be reduced to writing and signed by both the parties thereto.

- 8. The first party will provide special discount of 20% on all OPD consultation (In-house Consultants only).
- The first party will also provide special discount of 10% on total hospitalization bill 9. excluding pharmacy, consumables, and outsourced services.
- The first party will also provide special discount of 12% on Health Checkup Packages of 10. the hospital.
- 11. The first party will also provide special discount of 15% on OPD investigations (In-house only)
- 12. The second party will publish advertisement of the first party in its newsletter 4 times in a year.
- 13. The second party will facilitate the first party for basic health check-up camp, health seminar, health Talk and training from time to time in WIRC of ICAI group activity and the first party will arrange activity without any charges.
- 14. The same terms and conditions shall be applicable for our second unit "Star Synergy Hospital, Mavdi Main Road, Rajkot"

#### 15. Termination:

- a. Either party may terminate the contract by issuing one month's prior notice, in writing to the other party.
- b. In case of termination of the agreement, the hospital shall remain responsible for all assignments being attended to by the hospital at the time of termination of the agreement.
- c. Breach of contract and consequences thereof: Not withstanding anything contained in this MOU to the contrary, in event of breach, by either Party of any terms of his MoU, The first party/The second party shall have the right to terminate this MoU, immediately and without any notice period.

- d. In the event of any question, dispute or difference arising between the parties relating to the interpretation and application of these provisions of this agreement, such disputes or differences shall be resolved amicably by mutual consultations and on failure to do so shall be referred to the arbitration. The provisions of Arbitration and Conciliation Act, 1996 and any statutory modification or re-enactment thereof shall apply to the arbitration proceeding.
- 16. This agreement shall be governed by and construed in accordance with the laws of India and jurisdiction of court shall be at Rajkot.
